This contract for the personal service of artist and entertainers, made between the undersigned Purchaser (hereinafter called the “Purchaser”) and F& F Production (hereinafter called “F & F Production LLC”) Agent.

Compensation agreed upon: \$ 7,200.00
There will be no deductions for shows
canceled due to inclement weather.

Deposit Required: \$0.00

Balance is payable upon demand on the day of event, payable in U.S. funds by cash, money order, cashiers check.

Be it further agreed:

1. Purchaser is to provide the following at no charge to the artist:
 - A. Flat level area approx. 50' X 85' on solid firm ground (See attached layout) not located next to the sound stage or noisy carnival rides.
 - B. Two separate dedicated 20 amp, 110-volt electrical outlets or 30 amp 220-volt direct wire within 50' of unit. Available 24 hours a day. (the USDA rules are now requiring the animals in the trailer to be air condition)
 - C. Access to water within 50' of unit. Available 24 hours a day.
 - D. Any water or electrol connection that must cross a public walk way or road will be done by the purchaser
 - E. Show area available for setup a minimum 24 hours prior to start of first show.
 - F. Any Special passes required for parking and entrance by artist to enter event.
 - G. 3 Bales of pine shavings, no lose saw dust. Grass in pig track area should be lawn cropped (taller grass will require additional bags of shaving)
2. This attraction is subject to all state and federal laws, permits and limitations.
3. All riders and attached to this contract automatically become a part of the contract.
- ~~4. The Purchaser agrees not to reproduce, perform any or all parts of the show for a period of two year after completion of this contract without a written agreement from F & F Production LLC.~~
5. Any appearance for any reason whatsoever other than herein stated times and places must be cleared by F & F Production LLC prior to show date.
6. This engagement is not to be advertised or publicized in any manner or form until this contract is fully processed and signed by both parties.
7. Purchaser assumes liability for all public areas out side of the fenced pig track and will provide lighting for these public areas.

- 8. In the event of sickness or of accident, mechanical break down or if a performance is prevented, rendered impossible or infeasible by any act or regulation of any public authority or bureau, civil tumult, strike, epidemic, interruption in or delay of transportation service, war conditions or emergencies or any cause beyond the control of the Entertainer, it is understood and agreed that there shall be no claim for damages by either party to this contract, and that the Entertainer's obligation as to such performances shall be deemed waived. In the event of such non-performance for any of the reasons stated in this paragraph, the monies (if any) advanced to the Entertainer) hereunder, shall be returned. Inclement weather rendering the performance impossible or infeasible shall not be deemed an emergency and payment of the agreed upon compensation shall be made notwithstanding provided, however, that Entertainer is ready, willing and able to perform pursuant to the terms hereof.**
- 9. If, on or before the date of any scheduled performance, the Purchaser has failed, neglected or refused to perform or honor any contract with any other performer for any earlier engagement, or if the financial standing or credit of the Purchaser has been impaired or is unsatisfactory, the Entertainer(s) shall have the right to demand the payment of the guaranteed compensation (wage agreed upon) forthwith. If the Purchaser fails or refuses to make payment forthwith, the Entertainer(s) shall have the right to cancel this engagement by notice to the Purchaser to that effect, and in such event, the Entertainer(s) shall retain any amount theretofore paid the Entertainer(s) by the Purchaser.**
- 10. Upon arrival of Entertainer(s) the Purchaser will determine where the Entertainer should set up equipment. Should conditions change and become unacceptable to the purchaser, after Entertainer(s) have begun to set up, the Purchaser is obligated to pay the Entertainer(s) upon demand. The Entertainer is not obligated to set up a second time.**
- 11. The Purchaser understands that outdoor events, in particular those without alternate indoor facilities are risky due to inclement weather conditions and that Purchaser is prepared to assume responsibility.**
- 12. Entertainer(s) shall have the right to sell souvenir, books, on premises of the place of engagement with out any participation in the proceeds by the Purchaser.**
- 13. In the event of litigation, F & F Production LLC shall be entitled to recover any and all reasonable cost including attorneys' fees, expenses and court costs incurred in the enforcement of the terms of this Agreement, or any breach thereof.**
- 14. It is also understood that Purchaser will be responsible for any and all entertainment taxes and performance tax, if any.**

15. This contract becomes void if purchaser fails to sign and return it within 15 days of dated issued.
